Please note that every traveller entering the Maldives, must have a valid negative PCR test result for Covid-19, issued by a lab duly registered by the competent authority in the country of origin. The swab sample must be taken no more than 96 hours prior to the scheduled time of departure from the first point of embarkation en route to the Maldives. This test, requested by the Maldivian authorities, is mandatory and applies to all tourists and short term visitors of all ages, except for infants 0-12 months of age.

Furthermore, LUX\* North Male Atoll Resort & Villas strongly recommends traveling with a valid travel insurance covering all Covid-19 related incidents.
